### **Step 3 Net Metering Agreement**

SMPA uses a 3-step process for members to obtain approval for the installation and net metering of qualifying electrical generation systems. This Application is considered **Step 3** and follows the successful completion of the 2 step **Net Metering System Approval Application**.

This form is used to secure the SMPA Net Metering billing rate. After completion of this last step, the Net Metered rate status will be reflected in the member's next regular billing statement with any excess generation being "banked" for future use or credit, as described in the **SMPA Net Metering Policy**.

Attachments to this document also include forms for the transfer of the Net Metering billing rate to renters or the transfer to new owners, due to the sale of the facility that houses the system.

### **Net Metering Agreement**

Member Applicant hereby agrees to assign all Renewable Energy Credits (RECs) produced from the installation covered under this agreement to San Miguel Power Association.- Applicant/Customer represents they will not claim the RECs produced under this agreement for any purpose and shall not allow any other entity to claim said RECs.

Member Applicant hereby covenants and agrees to assume all risk of and liability for personal injuries (including death) and damage to property arising out of or caused by the operation of the System. Member Applicant hereby covenants and agrees to indemnify, protect, defend and save harmless SMPA, its affiliates, officers, directors, employees and agents from and against any and all claims and demands for damages to property and injury or death to persons which may arise out of, or be related to, or caused by, the operation of the System or its interconnection to the SMPA electrical system, except if caused solely by the gross negligence or willful misconduct of SMPA as determined by a court of law.

I, the undersigned, have received the final **Step 2** approval in the **Net Metering System Approval Application** which accurately describes the equipment to be interconnected and operated in parallel with the Cooperative's distribution system. I have made a copy of completed **Net Metering System Approval Application** available to SMPA. I have read and understand the requirements found in the **SMPA Net Metering Policy**, including but not limited to the required Codes and Standards for the equipment installed, Liability Insurance requirements, Interconnection costs, SMPA Access, Disconnect Requirements, Quality of Service and Electrical Characteristics, and Net Metering Rate Schedule information. I understand that approval of this Application and execution of the Net Metering Agreement is dependent on compliance with these requirements and the accuracy of the information as included in this Application.

This agreement may be transferred to a renter (with the system owner's permission) and shall survive the transfer of ownership of the small generating facility to a new owner when the new owner agrees to comply with the terms of this agreement.

## **Attachment A: Transfer of Net Metering to a New Owner:**

This attachment allows the transfer of Net Metering to those who purchase a home or facility that has an existing approved Net Metered electrical generating system. The original Net Metering Agreement may be transferred to the new owner without having to undergo the first 2-step *Net Metering System Approval Application* process.

- 1. New Owner should obtain a copy of the original *Net Metering Agreement* from the original owner. Note this may be obtained from SMPA as well, even if it is a prior version of the agreement. The copy should be provided to SMPA, along with this signed attachment.
- 2. New Owner should review the technical details of the original system design and as built condition of the system.
- 3. New Owner should become familiar with the proper and safe operation of the system.
- 4. New Owner should review the SMPA Net Metering Policy.

### **Attachment B: Transfer of Net Metering to a Renter**

This attachment allows the transfer of Net Metering to those who rent a home or facility that has an existing approved Net Metered electrical generating system. The **Landlord Member and System Owner** has installed a qualifying Net Metered generation system and previously signed a *Net Meter Agreement*. The Renter can assume the benefits afforded by this system through their own SMPA electric service account with a Net Metering billing rate.

With this Agreement, the rental facility electrical generation (energy received) will be "netted" against the electric consumption (energy delivered). The Renter's Net Metered rate status will be reflected in the next regular billing statement with any excess generation being "banked" for future use or credit.

Both the **Renter Member Applicant** and the **Landlord Member and System Owner** are required to sign this form.
