# There's More Than One Way to Store Energy: **Electric Thermal Storage and Time-Based Rates**

Proactively timing household energy use can help lower costs, ensure balanced revenue recovery, and reduce carbon emissions, but how can electric consumers time their energy use in a costeffective way, without sacrificing quality-of-life?

That's a question that some net-metered (rooftop solar) members are asking, as the possibility of an SMPA time-based rate grows. Net-metered members stand to realize significant savings if they can pair their generation systems with energy storage, allowing them to offset expensive, on-peak (4-9 PM) electricity with stored solar power that was generated relatively cheaply, during the day. With the rise in popularity of lithium-ion batteries (due to their use in electric vehicles and products like the Tesla® Powerwall) many are investigating electric batteries as a storage solution.


But there's more than one way to store energy...

According to the U.S Department of Energy, nearly half of energy used in U.S. Households is for climate control. For us, in the winter, that means space heating. There exists a technology that allows cheap solar energy to be stored as heat, and then deployed when the sun goes down. These appliances are called Electric Thermal Storage (ETS).

These systems use electric heating elements to convert solar electricity into heat, which is then stored in materials like ceramic bricks or water. This stored heat is released when needed, providing a reliable heat source without drawing electricity during peak times. An ETS system can be integrated into a home's heating system. This can include ETS furnaces, room heaters, or water heaters. Moreover, the price of an average ETS system can be less than a quarter of the cost of lithiumion batteries serving a similar purpose.

If SMPA does implement a time-of-use (TOU) rate, it may put net-metered members in a position to save money for themselves, lower rate pressure for their neighbors, and limit carbon emissions of the grid that serves them. Additionally, due to ETS's low upfront cost—compared to lithium-ion batteries—these consumers can break even in relatively short order, thereby increasing their return-on-investment.

Leveraging ETS technology may be a strategy to gain multiple benefits under a time-based rate. It's just one more way that we say, "Timing Matters."

# **Professional Excavators!**

## **NOTIFY**

Call 811 or make an online request at least 2-3 days before work begins.



2 days not including the day of notice.



## **CONFIRM**

Confirm that all affected utility operators have responded to your request and located accurately.



## **RESPECT**

Respect the utility marks (paint or flags).



# **DIG CAREFULLY**

Dig carefully. State laws generally prohibit the use of mechanized equipment within 18-24" on all sides of a marked utility.
